Currently, Jyotirmaye Textiles operates at an impressive production capacity of 45 tons per day, demonstrating its commitment to growth and innovation. The acquisition of Sri Venkateswara Spintex in 2022 further underscores their ambitious expansion strategy.

#### **PRODUCT RANGE AND MARKET REACH**

Specializing in coarse counts, Jyotirmaye Textiles has carved a niche in manufacturing ring-spun yarns ranging from 6s to 60s. The company supplies 6s, 10s, 12s, 16s, and 20s counts primarily to the Chinese and Taiwanese markets, while the 16s corded compact is exported to Germany. The company also serves both the domestic and international markets with 60s combed compact and 61s combed compact yarns, ensuring a diverse portfolio.



#### **COMMITMENT TO WORKFORCE AND SUSTAINABILITY**

What truly sets Jyotirmaye Textiles apart from its competitors is its strong workforce and organizational culture. The management credits its success to dedicated employees who ensure timely delivery and uncompromised quality. However, like many in the textile industry, the company faces challenges such as rising power costs, which have escalated to approximately 8.5 rupees per unit.



To combat this, Jyotirmaye Textiles has invested significantly in renewable energy, boasting a 10-megawatt wind power setup and a 2-megawatt solar power system, with an additional 2-megawatt solar power installation underway. This strategic move aligns with the company's vision of sustainable growth. Looking ahead, Jyotirmaye Textiles envisions expansion into weaving, already forming a joint venture with Tarakeshwara Textiles. The long-term goal includes venturing into garment manufacturing, bringing the company closer to the end consumer.
